5. Headteacher's report.

a) How are the teachers finding the 'lesson studies'? How did you choose the groups? What is the success criteria?

Some teaching staff were initially worried about the introduction of the group work, but they are all now finding it ok. The feedback since introducing this new idea has been good, staff are enjoying the opportunity to learn and share best practice. The next HIP visit will include time with the 'lesson studies', get involved and give practical support. The groups were chosen based on the key stages and the needs highlighted by OFSTED within them. The aim is to have a balance of staff within each group. It is proving helpful by sharing with teaching staff key phrases to use in class and modelling behaviour. The aim is to continue the lesson studies every year. It is too early to judge the outcome of this training. When the Head observes the lessons, the focus and reasoning behind them, this will be the success criteria for improved clarity of teacher instruction.

b) The number of applications to join in September has dropped to 17 so far, does this correlate to the number of visits? How does this compare to other local schools?

The school had lots of visits of potential parents, the school has not received any feedback from them. KL explained the applications and the breakdown of where the pupils are coming from. The low numbers are a worry and will affect the finances, but there will be additions throughout the summer holidays and before September. From what we know at this stage some local schools are also down on numbers and some have the same number they

c) The school's KS2 data is impressive compared with local schools, how can we share this with prospective parents?

KS and HP talked through the data with the governing board. The board felt the results would attract parents to the school and show the school's strengths. Some of the data is already on the website but the school could make it more obvious to prospective parents, perhaps by sharing in the local paper or on social media. The writing scores are thoroughly assessed. Teachers attend moderation clusters and are internally moderated. A greater depth score is hard to attain.

d) What are the reasons behind the number of children leaving the school?

The children that have recently left the school have moved overseas or further away in the UK.

e) What is the explanation for the length of exclusion?

KS gave limited detail on the exclusion as it is an ongoing case, and the school is currently working with the CPLSO and STEPS county lead. The length of exclusion is decided by the Head and is for the safety of the pupil and the staff. KS has followed the appropriate steps and informed the Chairs of the Committee. All documents are being filed according to the guidelines. Governor requested that if the pupil is SEN that this is also considered going forward. NFH and AF to support KS.
